Opinion

We have audited the accompanying financial statements of KTBF NIDHI LTD. ("The Company"), which comprise the Balance Sheet as at 31st March 2026 and the Statement of Profit and Loss, and Statement of Cash flow statement, for the year ended 31st March 2026 and the Notes to the Financial statements including a summary of the significant accounting policies and other explanatory information.

The Company has recognized such TDS credits in the current year in line with Form 26AS reporting, while disclosing that the underlying transactions relate to prior years. Our opinion is not modified in respect of this matter.

Information other than the Financial Statements and Auditor's Report Thereon

The Company's Board of Directors and Management is responsible for the preparation of the other information. The other information comprises the information obtained at the date of this auditor's report but does not include the financial statements and our auditor's report thereon. The Company is in the process of getting the interest on such Income Tax paid under Protest.
 - II. An GST Demand is Pending before the Appellate Authority pertaining to FY 2019-2020. The Company had paid an amount of Rs.0.45 lakhs, and filed the Appeal.
 - III. The Company did not have any long-term contracts including derivatives contracts for which there were any material foreseeable losses.
 - IV. There were no amounts which required to be transferred by the Company to the Investor Education and Protection Fund.
 - V(I). - h) The company has not paid any managerial remuneration during the year, and hence commenting about compliance of sec 197 does not arise.
